

List of changes proposed to Statement of Purposes and Rules

24 June 2020

Introduction

The Statement of Purposes and Rules of AACE Australian were originally developed and lodged with Consumer Affairs Victoria (CAV) together with our incorporation which was certified on 9 May 2019.

These original rules were drafted based primarily on the model rules provided by CAV with some additional clauses and terminology adopted from the Sample Section Rules provided by AACE.

The Section has now operated for over 12 months and during this time the board has progressed the development of its operational procedures and governance policies to ensure the organisation works effectively and efficiently on behalf of its members while recognising the Board members are volunteers, many with full time work responsibilities. As part of this the Statement of Purposes and Rules have undergone substantial review and revision from its original draft submitted for incorporation and this revision will be put forward to members to vote for their adoption as a special resolution at the inaugural annual general meeting on 5 August 2020.

This document details the proposed changes to the Statement of Purposes and Rules that were moved and accepted unanimously at a Board meeting on 24th June 2020. The key emphasis of the revision includes:

- Changing the name of the Section's managing body from "board" to "committee".
 The terminology "board" was initially adopted to align with the AACE Sample Section Rules which is aligned with US terminology, but the term "committee" better aligns with the Australian terminology for incorporated associations and has been adopted to avoid misinterpretation that the organisation is operating as a company.
 Henceforth in this document the board will now be referred to as committee
- Changing the name of "Director" to "Ordinary Committee Member"
 Similar to the above point, we propose changing the term "Director" to "Ordinary Committee Member" to better align with Australian terminology for incorporated association and to avoid misinterpretation
- Term of office changed to one year with re-election possible at each AGM to the simplify process and ensure members can be attracted to serving on the committee
- Revision of membership application process to align with actual practice with AACE
- Revision of disciplinary process to align with actual practice with AACE
- Revision of ballot process to align with actual practice
- Revision of management of funds to allow functional operation of bank accounts and enable payment processes particularly considering the geographical separation of the committee
- Removal of the requirement for the use of Common Seal which is optional under the Act
- Removal of Part 8 related to Business Meetings
 Procedures for subcommittees and any other general business meetings of the Section will be dealt with either via 1) terms of reference for each subcommittees or 2) internal policies and procedures. It was decided by the committee that these matters need not be included in the Statement of Purposes and Rules and could cause confusion to the reader. Instead the Statement focuses on General Meetings, Special Meetings and Committee Meetings.
- Standardisation of numbering Adopted use of outline numbering i.e. 1, 1.1, 1.1.1, 1.1.1 etc) to improve readability and cross-referencing within the document



- General formatting of document with cover page, revision history, header and footer and standardised paragraph formatting
- General correction of grammatical and spelling errors

The following changes were made throughout the document

- 1. Replaced "association" with "Section" when referring to the organisation
- 2. Replaced "board" with "committee" when referring to managing body
- 3. Replaced "Officer" with "Office Bearer"
- 4. Removed Associate members
- 5. Renumbered outline numbering for clauses and updated cross referenced clauses
- 6. Removed cross references to deleted clauses as applicable
